COUNTRY BACKGROUND

COUNTRY OVERVIEW

- General statistics: population including rural/urban split, fragility (fragile v. strong)
- Geographic areas: where you are working (at what levels – national, sub-national), terrain, biomes/ecosystems
- WASH statistics from The WHO/UNICEF Joint Monitoring Programme for Water Supply, Sanitation and Hygiene (JMP) (add local statistics if you have them—sub-national level)
- Finance statistics: GDP, % of people living below the poverty line
- When is the next election cycle?

PROGRAM OVERVIEW

PROGRAMMATIC WORK OVERVIEW

- What is the key objective of your work related to the integration of freshwater conservation and WASH?
- How does this work align with your organizational priorities at country level?

POLITICAL LANDSCAPE

POLITICAL OVERVIEW

- List of relevant ministries and their functions (What topic area are they responsible for?
Example: Who is responsible for rural water supply?)
- Who are the decision-makers at these ministries?
- Which of these ministries do you and/or your colleagues interact with?
- How do you and/or your colleagues interact with these ministries and individual decision-makers?
- How does the national level government interact with the sub-national level?

POLICY LANDSCAPE

POLICY OVERVIEW

- What policies are relevant and/or relate to your work?
 - Describe how these policies are important to the problem. (*Note: Policies can include laws, standard treatment protocols, policy implementation guidance, government strategies, etc.*)
 - Include any area of need where there may not be an existing policy, but you see a need and/or an opportunity for one.
 - Feel free to include this information in a table.
- Describe the policy development process in your country.
 - How are policies made and enforced?
 - Have you or your team contributed to the development of these policies?

KEY PLAYERS

PARTNER AND OTHER STAKEHOLDER OVERVIEW

- List the top three major players or leading voices for conservation/biodiversity, community access to water, sanitation, and hygiene in your country. (*Think about organizations, interest groups, NGOs, private sector entities, individuals, or coalitions that are currently working on the issue.*)
- Identify the most influential players that may or may not be listed above but would be required for making a policy or funding change that impacts freshwater biodiversity, WASH, and/or watershed management.

DATA AND EVIDENCE

DOCUMENT OVERVIEW

- List critical programmatic or technical documents or research that could support your position on the issue. *(This could be information developed by your organization or broad literature on the issue.)*
